#### Road and Parks Report:

Road Foreman was excused. Bricker reported that in December, 1,458 miles were put on trucks. They used 35 gallons of diesel and 136 gallons of gasoline. There were 5 weather events and they used 58 tons salt mix. They applied three tons of cold patch.

The department hauled no limestone. There were no burials or cremations. They poured zero head stone foundations. There were no culvert installations.

Bricker thanked the road crew for keeping the roads clear and for changing out the compressor in the basement of the administration building.

#### Fire Report:

Mesler submitted the report for April 2024.

Damascus Fire Department responded to 55 out of 55 calls for the month of December:

40 medical calls (Goshen – 22, Butler – 11, Sebring – 4, Winona – 2, North Georgetown - 1),

- 1 MVA with injuries (Goshen -1),
- 1 MVA without injuries (Goshen -1),
- 2 Fire alarms (Goshen -2),
- 1 Lift Assist (Butler 1),
- 5 Trees/Wires Down (Goshen -4, Butler -1),
- 2 Gas Odor Investigation (Goshen 1, Butler 1),
- 1 Structure Fire (Salem 1),
- 1 Explosion Investigation (Goshen -1),
- 1 Train Fire (Salem -1).

There was one inspection and the department had 135 training hours.

#### Police Report:

Police Chief John Calko presented the stats for the month of December:

Goshen:

6,855 miles driven with 614 events

Green:

7.678 miles driven with 339 events

Calko provided the end of year for the department.

Goshen:

86,974 miles driven with 4624 events

Green:

89,727 miles driven with 3750 events

Calko provided 2023 year-end reports for Drug Law Enforcement Fund (2221) and Law Enforcement Fund (2908)

Bricker thanked Calko for the hard work he put in this past year keeping everything going.

#### **Trustee Items:**

Mesler made a motion to sign the Thomas Fok & Associates contract for their engineering services for South Duck Creek Road Resurfacing Phase 2. Bricker seconded. Voting YES – Bricker, Stratton, Mesler. Motion carried.

The trustees signed the contract.

Mesler read the proposed dates of the legal advertisement schedule:

- 1st Adv = Tuesday February 18, 2025
- 2nd Adv = Tuesday February 25, 2025
- Bids Due = Tuesday March 11, 2025 at 2pm Goshen Township Police Department
- Bids Open = Tuesday March 11, 2025 at 6pm at Goshen Township Trustees

FOK will add a sentence to the Legal Notice stating that the project will not commence until at least Tuesday July 08, 2025 and that it shall be completed by no later than Tuesday September 09, 2025.

Mesler made a motion to approve dates. Bricker seconded. Voting YES – Mesler, Stratton, Bricker, motion carried.

Bricker made a motion to sign the new contract with Cintas for the Road crew uniforms. Stratton seconded. Voting YES – Bricker, Mesler, Stratton. Motion Carried.

Mesler was contacted by a property owner about a large tree in the road right of way. Property owner is requesting that the township cut the tree down and he will remove it.

Mesler made a motion to get prices and have the tree taken down. Stratton seconded. Voting YES – Stratton, Bricker, Mesler. motion carried.

Bricker is having a repair person get a price to switch from air to electric for the heat exchanger in the gym.
